ORDER:

The amendment suggested by the Principal Secretary and Commissioner of Revenue Administration in his letter read above is approved. The following amendment is issued to the Tamil Nadu Government Office Manual.

AMENDMENT.

In the said Manual, for the heading "Ink to be used in Office" for paragraph 14A, the following paragraph shall be substituted, namely,-

"14A. INK TO BE USED IN OFFICE.- Fountain pen, ball point pen and gel pen can be used for writing by staff / officers in Government records. Ink in Permanent Blue / Blue Black or Black Colour only manufactured by a Standard Company should be used by Officers and staff for writing in the records of all Government Offices. Provided.

- a) The Officers who are permitted to attest true copies of certificates testimonials etc, as per the orders issued in G.O(Ms)No.189, P&AR(S) Department, dated 18.07.2007, may use green ink while making attestation.
- b) Group 'A' officers may use green ink to write brief notes in files".

2. The Principal Secretary / Commissioner of Revenue Administration is requested to take necessary action for issue of correction slips to the Tamil Nadu Government Office Manual.
