ORDER:-

In the G.O.read above, orders have been issued extending the benefit of family pension scheme to the retiral spouses from the date following the date of death of the pensioner, irrespective of the date of retirement. The Govt. of India in their O.M. second read above, have prescribed certain procedure for endorsement of family pension entitlement of post retiral spouses in the pension Payment Order of Central Govt. Civil Pensioners.

2. The Govt. have carefully examined the procedure prescribed by the Govt. of India in respect of Central Govt. Civil Pensioners and have decided to adopt them in respect of State Govt. pensioners. Accordingly, the Govt. direct that the following procedure shall be followed for endorsement of family pension entitlement of post retiral spouses to the Pension Payment Order of State Government pensioners:-

i) If a pensioner marries or re-marries after retirement, he shall intimate the event to the pension sanctioning authorities in the Application prescribed in the Annexure to this order. He shall also furnish along with his application an attested copy of the marriage certificate from the Registrar/Village Panchayat/District Magistrate in respect of post-retirement marriage:

ii) The Pension Sanctioning authorities after due verification of the application shall forward it to the Accountant General (Accounts and Entitlements) for issue of corrigendum Pension Pay Order. While forwarding the papers to the Accountant General (Accts. and Entitlements) the provisions of clause (b) of sub-rule (7) of Rule 49 of the Tamil Nadu Pension Rules 73 shall be kept in mind. If the pensioner does not have any child or children from his previous marriage, the post-retiral spouse shall be eligible for full family pension. If the pensioner has an eligible child or children from another wife who is not alive, family pension to the post retiral spouse and the child/children from the previous marriage shall be authorised in terms of clause (b) of sub-rule (7) of Rule 49 of the Tamil Nadu Pension Rules 73.

iii) The corrigendum Pension Pay Order shall be forwarded by the Accountant General (Accounts and Entitlements) to the Pension Disbursing Officers and a copy of the Corrigendum Pension pay Order shall also be endorsed to the pensioner.

iv) A fresh Pension Pay Order should be issued by the Accountant General (Accounts and Entitlements) in respect of eligible children including those born after retirement as and when their turn come up.

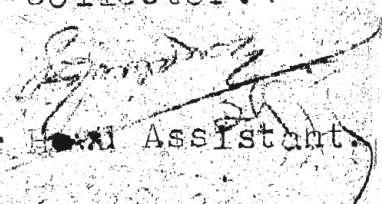
