### ABSTRACT

**ADVANCE** – Tamil Nadu Government Servants' Family Security Fund Scheme – Advance for meeting the immediate requirement of the families of Government servant who die while in service – Enhancement of the amount of advance - Orders - Issued.

#### ORDER :

In the Government Order first read above, orders were issued enhancing the amount of advance from Rs.2,000/- to Rs.5,000/- for meeting the immediate requirement of the families of Government servants including All India Service Officers belonging to the Tamil Nadu Cadre (excluding casual and daily rated employees and those working on contract basis) who die while in service. It was also ordered that the advance shall be adjusted against the lumpsum amount to be paid under Tamil Nadu Government Servants' Family Security Fund Scheme later on. In the Government Order second read above, orders were issued enhancing the lumpsum amount from Rs.1,00,000/- to Rs.1,50,000/- as a measure of support and security to the families of Government employees including employees on consolidated pay and honotarium both part time and full time, who die in harness on or after 1-2-2006. It was also ordered that the contribution made by the Government employees shall be enhanced from Rs.20/- to Rs.30/- per month with effect from the month of February 2006 which will continue till the superannuation of the Government servants.

**2.** While moving the Demand No.50 Pension and Other Retirement Benefits - 2015-2016 for grants on 29-09-2015, the Hon'ble Minister for Finance and Public Works announced the enhancement of advance amount from Rs.5,000/- to Rs.25,000/- for meeting the immediate requirement of the family of Government servant who die while in service.

**3.** Accordingly, the Government direct that the amount of advance from Tamil Nadu Government Servants' Family Security Fund Scheme be raised from Rs.5,000/- to Rs.25,000/- (Rupees Twenty Five Thousand only) for meeting the immediate requirement of the families of Government servants including All India Service Officers belonging to the Tamil Nadu Cadre (excluding casual and daily wage employees and those working on

contract basis) who die while in service. The Government also direct that the advance drawn be adjusted against the lumpsum amount to be paid under Tamil Nadu Government Servants' Family Security Fund Scheme.
