ORDER:-

The Government have implemented the scheme of sanction of incentive increment for having acquired higher qualification by various categories of Teachers by issuing the Government Orders 1 to 7 read above. They have also implemented the scheme of advance increment for Teaches training qualification obtained by the various categories of Teachers as per the Government Orders referred to in 7 to 13 read above.

- The Fifth Pay Commission has recommended that incentive increment presently available for acquiring higher qualification may be continued but higher start for teacher's training qualification should e withdrawn for future recruits.
- 3. The Government accept the recommendations of the Fifth pay Commission. They accordingly direct that the incentive increment presently available for acquiring higher qualification by the Teaches be continued. However, sanction of higher start advance increment for Teacher's Training qualification obtained by various categories of teachers be withdrawn for persons recruited with effect from 27.6.89, (the date from which orders on Tamil nadu Revised Scales of Pay Rules of 1989 were issued).
- 4. This order issues with the concurrence of the Finance Department vide its U.O.No.54513/PCII/90-1, dated 28.5.90.
