ORDER:

The Govt. in their G.O. second read above, ordered that persons retiring from Govt. Service in teaching or other posts in any of the Departments concerned with Education under the Control of Secretariat Education Department Viz. School Education, Collegiate Education, Technical Edn. Govt. Examinations, SCERT, Non Formal& Audit Education, Legal Studies etc. be permitted to count the periods of Service rendered by them as teachers in any recognised non-Govt. (i.e Aided or local body) Edl. Institution, Subject to the condition that they should surrender to the Govt. the Management's as well as the Govt. contributions, if any, paid to their P.F. together with interest thereon. These orders were given effect from 16-10-71. It was also ordered therein that cases which a rose prior 16-10-71 would not, however be reopened.

 Thiru N. Balasubramanian, Supdt. O/o the DSE, has requested orders for counting his services from 1-8-55 to 9-5-59 rendered in a Non-Teaching post (Jt. Asst) in aided school Viz. S.K. Velayudham High School, Kurinjipadi, for purposes of pension. The Director of School Education has recommended his request.

- 3. After careful examination, the Govt. direct that persons retiring from Govt. service in non-teaching posts in any of the Dept. concerned with education under the administrative control of the Education, Science & Technology Dept., Secretariat, Fort St. George be permitted to count the periods of service rendered by them in non-teaching posts in any recognised non-Govt. (Aided or Local Body) educational institutions, subject to the condition that they should surrender to the Govt. the Management's as well as the Govt. contribution, if any, paid to their Provident Fund together with interest thereon. This order will be deemed to have come into effect from 16-10-71. Cases which arose prior to 16-10-71 will not however be reopened.
- 4. The Service Books of Thiru N. Balasubramanian, Superintendent are returned to the Director of School Education and he is requested to dispose of his case in the list of the orders issued in para 3 above. He is also requested to acknowledge the receipt of the Service books.
- 5. This order issues with the concurrence, of the Finance (Pen) Dept. Vide its U.O. No. 44585/83-dt. 19-4-83.
