Sub: Revision of Scale of Pay-post of Ministerial Superintendent - fixation of pay-w.c.f. 1:6.88 and 1.1.96 certain-clarification-issued.

I am to invite your attention to the references cited. The following clarifications are issued in regard to fixation of pay in the revised scale of pay ordered in the Government order third cited.

- (i) After regulating the pay as ordered in para 9 of G.O. third cited: if there is any drop in the Basic pay compared to the Basic pay and Personal pay already drawn as on 27.11.2000, the difference shall be allowed as personal pay as on 27.11.2000 and this personal pay shall be absorbed in future increments.
  - (ii) In respect of the employees already retired from service the pension fixed based on higher pay plus personal pay already drawn, need not be re-opened.

- (iii) In respect of the employees who were already promoted to any other higher post and if the pay already fixed based on the pay plus personal pay is higher than the pay now regulated as per the revised scales ordered in the Government order third cited, their cases also need not be re-opened.
- The fitment table for pay fixation from Rs.905-1545 to Rs. 1700-3005 and from Rs. 1700-3005 to Rs. 5700-9200 are annexed to this letter.
