## **ORDER:**

The Tamil Nadu Treasuries and Accounts Service Association has made representation before the Pay Grievance Redressal Cell to withdraw the wrongly given Grade Pay to the post of Sub-Treasury Officer as Rs.9300—34800 + Grade Pay of Rs.4900 in the Government Order second read above and to issue suitable amendment in this regard. The Pay Grievance Redressal Cell constituted in the Government Order third read above has observed that while issue of orders in respect of Treasuries and Accounts Department based on the recommendations of One Man Commission, 2010 the scale of pay of the post of Sub-Treasury Officer has been erroneously indicated as Rs.9300—34800 + Grade Pay of Rs.4900 equal to the level of promotion post of Assistant Treasury Officer. Therefore, the Committee has recommended to set right the scale of pay of the post of Sub-Treasury Officer by issuing suitable amendment by deleting the post of Sub-Treasury Officer included in the Government Order second read above and to waive the excess pay and allowances, paid if any drawn by the incumbent consequent on the refixation of pay in the appropriate revised scale of pay of Rs.9300—34800 + Grade Pay of Rs.4800. After careful examination the Government has decided to implement the recommendations made by the Pay Grievance Redressal Cell to fix the appropriate scale of pay of Sub-Treasury Officer in Treasuries and Accounts Department. Accordingly, the Government issue the following amendment to Serial No.2 of the Government Order second read above by substituting the following:--

2) The revision of scale of pay ordered in para-1 above shall take notional effect from 12—12--2007 for the purpose of fixation of pay in the revised scale of pay with monetary benefit from 1--4--2013. However, the excess pay and allowances, if any drawn by the incumbents shall be waived.
