From the Director of School Education Lr.Rc. No. 248500/81/84, dated 7.5.85 and letter of even No. dt. 11.6.86.

ORDER:

Rev. Fr. Stanislaus M. Fernandez, Headmaster, St. Bade's Anglo Indian Higher Secondary School, Madras (Since transferred by the Don Bosco Organisation to Carmel Higher Secondary School Nagarcoil Kanyakumari (Dt.) has represented that he is a Headmaster from 1964 and that while fixing his pay for grant purpose, the Director of School Education, has deleted his service put in the following Institutions.

- 1. Don Bosco Matriculation School, Panaji, Goa from 1.6.66 to 13.6.68.
- 2. Don Bosco Matriculation School, Madras from 4.6.73 to 23.5.80.

Fr. Stanislaus has requested that his service in Don Bosco Matriculation School, Madras may be taken into account for purpose of fixing of pay for grant purpose.

- The Director of School Education has stated that as per GO.Ms. No. 2056, Education, dt. 30.12.76.
- 3. The Pay of Fr. Stanislaus for grant purpose was therefore fixed at Rs. 750/- in the scale of Rs. 750-30-1350 with effect from 24.5.80 with date of next increment on 1.4.81.
- From 1978-79 Don Bosco Matriculation School is under the control of the Director of School Education (prior to that, it was under the control of the University of Madras)
 This school adopted Government scale of pay in respect of Headmaster from 4.6.1973.
- 5. If the service put in by Fr. Stanislaus in Don Bosco Matriculation School, Egmore, Madras is permitted by the Government to be counted for purpose of fixation of pay, the Director of School Education has stated that his pay can be fixed at Rs. 1000/- on 24.5.80 St, Bede's Anglo Indian Higher Secondary School, Madras on the date of his next increment fixed as 1.4.82 (the present scale of pay of Headmaster is Rs. 1340-2435).
- 6. The Director of School Education has reported that the services rendered in unrecognised schools are not taken to account for purpose of fixation of pay and pension, and that as per G.O.Ms. No. 37, Education, dated 5.2.83, the services rendered in recognised but unaided schools can be taken into account for fixation of pay and pension. The Matriculation schools are now recongnised but they are unaided.
- 7. In the cirumstances, the Director of School Education has recommended that the request of Fr. Stanislaus to count the services put in by him in Don Bosco Matriculation School, Egmore, Madras for purpose of fixation of pay may be considered as a special case, as he has been found to be a devoted and sincere teacher with good credentials a state awardee and an outstanding educationist. The Director of School Education has stated that at present, the Headmaster is losing Rs.250/- per month, and this will effect his pension.
- 8. The Government accept the recommendation of the Director of School Education and permit the Director of School Education to count the services put in by Rev.Fr. Stanislaus as Headmaster, Don Bosco Matriculation School, Egmore, Madras from 4.6.1973 to 23.5.1980 and to refix his pay with consequential benefits for grant and pension purposes for the following reasons.
 - Matriculation schools which were previously under the control of the University of Madras are now under the control of Director of School Education.

- b) Don Bosco Matriculation School, Egmore, Madras is adopting Government scale of pay for Headmaster.
- c) As per GO.Ms. No. 37, Education, dated 5.1.83, the service rendered in recognised unaided schools can be taken into account for fixation of pay and pension.
- d) The Matriculation schools are now recognised but they are unaided. (They are feelevying schools and the staff are paid their salaries from out of the income received from the collection of fees from the Students.)
- 9. This order issues with concurrence of the Finance Department vide its U.O.No. 139727, Education / 86-1, dated 18.2.86.
