The Government have introduced the Tamil Nadu Government Employees Special Provident Fund-cum-Gratuity Scheme with effect from 1-4-1984. According to this scheme, all regular, Government employees' under Tamil Nadu Government including persons on Foreign Service and on deputation and the All India Service Officers belong to Tamil Nadu Cadres are required to pay a uniform rate of Rs. 20/- per month till one month prior to the date of superannuation or till the subscription together with interest thereon adds upto Rs. 5,000/- whichever is earlier. In the case of an employee retiring on superannuation he will be paid the actual amount of subscription recovered from him together with interest thereon and in addition, the Government will be contributing a fixed amount of Rs. 5,000/-. In all other cases of retirement i.e. Compulsory retirement, retirement on medical invalidation etc. including death while in service the actual subscription made by him together with interest thereon will be alone paid. Further in the G.O. fourth read above, the Government have issued orders, allowing the Government contribution of Rs. 5,000 in the case of voluntary retirement with effect from 30-8-93.

2. The Government have considered the question of giving the Government contribution of Rs. 5,000/- in the case of medical invalidation and decided to allow the Government contribution in the case of persons who retire on medical invalidation as an incentive to such medically invalidated Government Servants. Accordingly, the Government direct that the following amendment be issued to Rule 9 of the Tamil Nadu Government Employees' Special Provident Fund-cum Gratuity Rules. This amendment shall take effect from the date of these orders.

## Amendment

For the existing rule 9 of the above rules, the following shall be substituted.

"Final payment in the event of superannuation or voluntary retirement with effect from 30-8-93 or retirement on medical invalidation etc.

In the case of an employee retiring on superannuation or voluntary retirement with effect from 30-8-93 or on medical invalidation with effect from 30-4-94 he will be paid the actual amount of subscription recovered from him together with interest thereof as per the table of repayment. In addition, the Government will be contributing a fixed amount of Rs. 5,000/- (Rupees Five thousand only). In all other cases including death while in service, the actual subscription made by him till then together with interest thereon will be paid.

In the event of death while in service the amount will be paid to his nominee or legal heirs"
